Opt-out confirmation

I understand that your records reflect that I am an accredited investor as defined in section 4A(1)(a) of the Securities and Futures Act 2001 (the "SFA") in relation to all Private Bank accounts and services with the Singapore branch of Barclays Bank PLC ("Barclays Singapore") and, where applicable, all Private Bank accounts and services with Barclays Bank PLC (London/Jersey/Isle of Man/Monaco) or Barclays Bank (Suisse) SA (each, a "Barclays Offshore Platform", and collectively with Barclays Singapore referred to as "Barclays" or "you").

I hereby request to opt out of the "accredited investor" status, and hereby notify you that I do not consent to being treated by you as an accredited investor.

I confirm that I have been provided with a copy of all of the consent provisions which apply to accredited investors ("consent provisions"). A copy of the consent provisions can be found at https://privatebank.barclays.com/support-and-information/terms-and-conditions/. I have noted that the consent provisions set out the regulatory requirements that Barclays will be exempt from when dealing with an accredited investor.

I further understand that:

- My request to opt out of the "accredited investor" status would apply to all my account(s) opened with Barclays, my transaction(s) booked with Barclays, and the relevant services and products offered by or through to me where I act as principal solely for my own account (including joint accounts).
- By opting-out of the "accredited investor" status, you would need to treat me/us as a retail customer. This means that Barclays would no longer be able to offer or provide services and products to me and/or execute certain transactions for me.
- As a retail customer there may be restrictions on the dealings that you can effect for me for my existing
 investments and/or transactions booked with Barclays.
- My withdrawal of consent is subject to a processing period of not more than three (3) months from the date of
 receipt of this instruction and you will notify me once my request has been processed by you and my investor
 status has been updated in your records, upon which you will not treat me as an accredited investor for the
 purposes of all of the consent provisions. I acknowledge and agree that until such time, I would still be treated as
 an accredited investor by you.

Consent to Disclosure

I consent to you disclosing the fact that I have withdrawn my consent to be treated as an accredited investor, as specified above, to any person that relies on my "accredited investor" status to be qualified as an accredited investor.

To the extent that I have a joint account opened/to be opened with you (the "Joint Account(s)"), I consent to you disclosing to all other joint accountholders of the Joint Account(s) that I have withdrawn my consent to be treated as an accredited investor, as specified above.
